# Czech - Norwegian Research Programme

## Main implementing actors:

**Donor Programme Partner:** Research Council of Norway (RCN) – preparation of Programme proposal, advisory and supervising body, contact and information point

**Programme operator :** MEYS – preparation of the Programme, announcement of calls, receiving of projects proposals, formal decision maker, programme management, contact and information point

**Programme committee** (3CZ+2NO) – strategy (wording of calls), selection process, monitoring

**Experts** – evaluation of projects proposals (EU database )

**Project Promoters/ Project partners** – Czech and Norwegian R and D organizations

# Czech – Norwegian Research Programme

## Overall objectives

- to enhance the science and research cooperation between Czech and Norwegian entities
- to fund the creation of new scientific knowledge and quality outputs through bilateral science and research projects in selected areas of research in the frame of basic and applied research and experimental development

# Czech – Norwegian Research Programme



## Important objectives

- promotion of creation of long term sustainable partnership between Czech and Norwegian institutions
- support of young researchers (involvement of Ph.D. students and postdocs in a project), gender equality
- involvement of researchers who have returned after maternity leave
- promotion of mobility of young researchers closely linked to the project

# Czech – Norwegian Research Programme

## Some examples of what is expected to be achieved by the cooperation projects

- Internationally refereed (*joint scientific*) publications published on the basis of the results of the project
- Close cooperation between the partners involved in the project from the Czech Republic and Norway with the aim of building sustainable cooperation for future activities
- Active involvement of female researchers
- Active involvement of Ph.D. students and postdocs in the project
- Involvement of researchers who have returned after maternity leave
- Knowledge transfer, sharing of experience and best practices

# Czech – Norwegian Research Programme



## Selected areas of research

- Social sciences and the Humanities,
- Environment ,
- Health.

Interdisciplinary projects are welcome.

At least 20% of the call amount shall be allocated to projects of „Social sciences and the Humanities“

# Czech – Norwegian Research Programme

Ministry of Education, Youth and Sports has prepared its budget in order to be able to provide:

the **Programme – co-financing at the level of 15%** (as indicated in the slide above) and on top of it

The **Projects – co-financing at the level of 20%**  
(MEYS will add 20% to sum allocated for the CALL in the Programme)



# Czech – Norwegian Research Programme



## Who may apply

**Research Organisations** as defined by Article 2.2(d) of the Community Framework for State Aid for Research and Development and Innovation (2006/C 323/01)  
and / or

**Small and Medium-sized Enterprises** as defined in Article 2.2 (a) of the Community Framework for State Aid for Research and Development and Innovation (2006/C 323/01)

# Czech – Norwegian Research Programme



## Core condition:

**Cooperation between at least one research team from the Czech Republic and at least one research team from Norway (Project Partner) is a mandatory criterion for the projects.**

# Czech – Norwegian Research Programme

## Selection criteria

- Scientific and/or technical excellence
- Relevance in relation to the objectives and prioritised areas of the research programme
- Quality and efficiency of the implementation and management, including quality and implementation capacity of the applicants and contribution to capacity and competence building
- The potential impact through the development, dissemination and use of project results

# Czech – Norwegian Research Programme

## Selection process

- Based on the evaluations of independent experts, ranking list is prepared. The ranking list shall be submitted to the Programme Committee for a recommendation as to which proposals should be selected for funding and the final awarding of grants.
- The Programme Operator in cooperation with the Programme Committee will make its decision to finance/refuse an application on the basis of the ranking list and recommendations received from the Programme Committee.

# Czech – Norwegian Research Programme



## **Tentative timetable**

- **Matchmaking event** for project partners: 30.-31.5. 2013
- **Opening of the call:** June 2013
- **Closure of the call:** 2 months after the opening of the call
- **Planned start of the projects:** November / December 2013
- **Eligibility of project expenditures until:** 30.4.2017
