	External reallocation:
	PA 4a was cut by funds reallocated for OP HRE in the amount of 38,744,673 EUR. Funds amounting to 4,332,084 EUR were transferred from PA 4b and PA 5b (Support Area 5.1b) to OP PA.
	Cuts in the allocation of the programme as a whole shall also have an impact on the amount of technical assistance, which must not exceed 4% of the programme allocation in accordance with the Council Regulation (EC) No 1083/2006. For this reason, the allocation of Priority Axis 5 was reduced by 1,692,538 EUR. Funds amounting to 1,677,520 EUR were transferred from Support Area 5.1a to PA 2 OP EC and from Support Area 5.1b, funds worth 15,018 EUR were transferred to OP PA.
	Internal reallocation:
	In PA 2, funds were reallocated for Support Area 2.2 (amounting to 16,471,229 EUR), Support Area 2.3 in the amount of 46,883,210 EUR from PA 3 (from Support Area 3.2) 44,299,731 EUR, from PA 4a 17,377,188 EUR and from PA 5a (from Support Area 5.1a) 1,677,520 EUR.
