Scientific Committee

- New Action Submission, Evaluation, Selection and Approval (SESA) procedure.
- Overall supervision and quality control of procedures related to the submission, evaluation and selection of proposals and the monitoring and final assessment of COST Actions.
- Validation of Independent External Experts.
- Review Panels.



Terms of reference for the Scientific Committee mandate

SC meets for two plenaries per year (probably more)

SC have the following main responsibilities:

- Selection of proposals: Identification of proposals that respond best to the COST mission and policies and the needs of the different research communities;

- Overall supervision and quality control of procedures for:

- evaluation of proposals implementation of COST policies
- monitoring and final assessment of COST Actions;

- Global analysis of the outcomes and impact of ended Actions;

- Scientific and technological advice for COST.



List of total 345 projects evaluated and ranked (max 64 – min 5 pts)

35 projects ranked for funding (max 64 – min 57 pts)

- No changes in ranking, no scientific comments, anonymity lifted
- Implementation of COST mission and policies
- ITC participation (50 %)
- Gender balance (60/40 40/60)
- Young scientist participation (Early Career Investigators, ECI, up to 8 y after Ph.D.)
- Recommendations for all proposals between the top-ranked ones to proposals in the grey area
- SC recommendations must be included in MoU and implemented before the evaluation of the first interim report

9 projects marked at the cutoff (all 56 pts, grey area)


- 5 selected voting by simple majority
- 4 waiting list



Figure 1: Country distribution of submitted proposals






